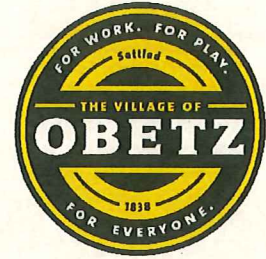


**VILLAGE OF OBETZ

**REGULAR MEETING OF AUGUST 12, 2019**

The Obetz Village Council met in regular session on August 12, 2019 at 6:00 PM at the Obetz Government Center located at 4175 Alum Creek Drive with Mayor D. Greg Scott presiding.

**ROLL CALL**

Mayor Scott called the roll with six Council members present. *Captain Wade Edwards, Hamilton Township Fire Department* – Captain Edwards discussed the EMT program at Hamilton HS. It is a partnership with Grant Hospital. It is an entire school year.

*Stacey Boumis, Community Services Director* – Ms. Boumis stated Planning and Zoning Commission is Wednesday.

*Stephen J. Smith, Esq., Frost Brown Todd* – No report.

*E. Rod Davisson, Esq., Administrator* – Mr. Davisson stated that there was a TIRC meeting today and staff is getting ready for Zucchiniest.



#### **REMARKS FROM THE AUDIENCE**


Andy Borders addressed Council. He stated that the Abbruzzee Brothers have a building that has not been maintained and it is adjacent to his property.
