AN ORDINANCE TO APPROVE AND AUTHORIZE THE VILLAGE ADMINISTRATOR TO PURCHASE REAL PROPERTY FROM JAMES MICHEL

WHEREAS, Section 3.01 of the Village Charter provides that Council has the power to acquire and to sell or otherwise convey interests in real property; and to lease, as the lessor or lessee, or otherwise grant or receive interests in real property; and,

WHEREAS, Section 157.04(j) of the Village of Obetz Codified Ordinances, provides that Council may authorize the purchase and sale of real property with or without public bidding, on such terms and for such value as Council, in the exercise of its discretion, may deem reasonable and in the best interest of the Village; and,

WHEREAS, the Village of Obetz and James Michel have come to mutually agreeable terms for the acquisition of property abutting Williams Road and land currently owned by the Village of Obetz and consisting of approximately 2 acres; and,

WHEREAS, the Village desires to execute necessary conveyance documentation to complete the transaction with James Michel.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF OBETZ, OHIO, THAT:

<u>Section 1.</u> Village Council hereby approves and authorizes the Village Administrator to enter into an agreement with James Michel to purchase Parcel Nos. 153-000017, 153-000004, and 153-000030 for approximately \$385,000 upon terms and conditions acceptable to the Law Director.

Section 2. This Council finds that such a purchase and transfer are in the best interests of the Village

<u>Section 3.</u> While the general terms of the purchase agreement have been finalized, Council recognizes that additional changes may be necessary to finalize the agreement with James Michel. Accordingly, the Village Administrator is hereby authorized to make necessary changes so long as they do not materially affect the terms and conditions approved herein.

Section 4. This Ordinance shall take effect at the earliest time permitted by law.
