AN ORDINANCE CREATING THE DIVISION OF UTILITIES, DIVISION OF STREETS, DIVISION OF FACILITIES, DIVISION OF RESEARCH AND DEVELOPMENT, AND DIVISION OF GROUNDS WITHIN THE DEPARTMENT OF PUBLIC WORKS, AND THE DIVISION OF ECONOMIC DEVELOPMENT WITHIN THE DEPARTMENT OF DEVELOPMENT AND ESTABLISHING THE POSITIONS OF SUPERINTENDENT OF UTILITIES, SUPERINTENDENT OF STREETS, SUPERINTENDENT OF FACILITIES, SUPERINTENDENT OF GROUNDS, AND DIRECTOR OF ECONOMIC DEVELOPMENT AND DECLARING AN EMERGENCY

WHEREAS, the Charter for the Village of Obetz was adopted by the electors at an election on November 3, 2009; and,

WHEREAS, the Charter sets forth requirements for Council to formally create certain divisions within departments as well as positions; and,

WHEREAS, there is a need for the Village of Obetz to create divisions within the Department of Public Works and Department of Development;

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF OBETZ, STATE OF OHIO, THAT:

Section 1. Pursuant to Section 6.05(B) of the Charter for the Village of Obetz, Council hereby creates the Division of Utilities, Division of Streets, Division of Facilities, Division of Research and Development, and Division of Grounds within the Department of Public Works.

Section 2. Pursuant to Section 6.05(B) of the Charter for the Village of Obetz, Council hereby establishes the positions of Superintendent of Utilities, Superintendent of Streets, Superintendent of Facilities, Superintendent of Research and Development, and Superintendent of Grounds.

Section 3. The Mayor shall take action pursuant to Section 6.05(B) of the Charter for the Village of Obetz and make appointments for the positions listed in Section 2 above.

Section 4. Pursuant to Section 6.06(A) of the Charter for the Village of Obetz, Council hereby creates the Division of Economic Development within the Department of Development.

Section 5. Pursuant to Section 6.06(A) of the Charter for the Village of Obetz, Council hereby establishes the position of Director of Economic Development within the Division of Economic Development.

Section 6. The Mayor shall take action pursuant to Section 6.06(A) of the Charter for the Village of Obetz and make appointments for the positions herein.

Section 7. Council declares this to be an emergency measure immediately necessary for the preservation of the public peace, health, and safety of this municipality and the further reason that the Village desires to create the necessary positions; WHEREFORE, this Ordinance shall take effect and be in force immediately upon passage by Council.
