
VILLAGE OF OBETZ RECORD OF ORDINANCES





PASSED: January 13, 2020

AN ORDINANCE TO REZONE VARIOUS PARCELS LOCATED THROUGHOUT THE VILLAGE OF OBETZ TO COMMUNITY FACILITIES

WHEREAS, the Village owns parcels throughout the Village that have various zoning classifications; and,

WHEREAS, the Village wants to rezone the parcels that contain public facilities or that are used for parkland to Community Facilities; and,

WHEREAS, the Planning and Zoning Commission initiated the rezoning of the parcels at its October 9, 2019 meeting; and,

WHEREAS, the Planning and Zoning Commission held a public hearing on the rezoning of the parcels at its November 13, 2019 meeting and recommended approval; and,

WHEREAS, the Council of the Village of Obetz held a public hearing on December 16, 2019 as part of the regularly scheduled Council meeting as required by the Codified Ordinances of the Village.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF OBETZ, OHIO, THAT:
