AN ORDINANCE NAMING THE SERVICE COMPLEX THE “KEVIN M. HALL SERVICE COMPLEX” AND DECLARING AN EMERGENCY

WHEREAS, Kevin M. Hall was born and raised in Hamilton Township. He was a standout athlete at Hamilton Township High School graduating in the class of 1990. Kevin married his high-school sweetheart Kristy May-Hall and together they raised two children—Brooke and Blake. After owning his own construction company for several years, Kevin came to Obetz as the Service Department Superintendent. In his time in Obetz, Kevin significantly expanded both the physical assets and service capabilities of the Service Department enabling the department to deliver the best possible services for the residents.

WHEREAS, beyond his obvious accomplishments, Kevin demonstrated a kindness and caring for the residents and employees that comes along rarely in public service. His dedication to the people who relied on him for service, guidance, or friendship was unparalleled.

WHEREAS, sadly, Kevin was taken from the Village far too early by cancer. In his time here, Kevin built a tradition of excellence; and, leaves a legacy of goodness in everyone he touched. Considering the foregoing, the Mayor and Council of Obetz hereby name Obetz’ Service Complex the “Kevin M. Hall Service Complex” to both honor his legacy; and, to remind us all that we can and should follow the example that Kevin set.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF OBETZ, STATE OF OHIO, THAT:

Section 1. Mayor Scott and Council desire to name the Service Complex the “Kevin M. Hall Service Complex” both to honor his legacy and to remind us that we can and should follow the example set by Kevin M. Hall.

Section 2. Council declares this to be an emergency measure immediately necessary for the preservation of the public peace, health, and safety of this municipality and the further reason that the Village desires to honor the memory of Kevin M. Hall; WHEREFORE, this Ordinance shall take effect and be in force immediately upon passage by Council.
