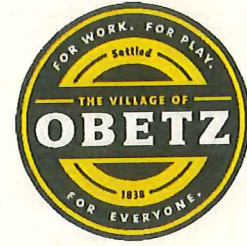


VILLAGE OF OBETZ  
RECORD OF PROCEEDINGS



REGULAR MEETING OF APRIL 27, 2020

As a result of the COVID-19 pandemic and the orders of Ohio Governor Mike DeWine, the Obetz Village Council held a live Council meeting over the internet utilizing Microsoft Teams on April 27, 2020 at 6:00 PM with Mayor Angela M. Kirk presiding.

**ROLL CALL**

Mayor Kirk called the roll with all six Council members present. Mr. Michael Flaherty – present; Mr. Robert Kramer – present; Mr. Guiles Richardson – present; Mrs. Bonnie Wiley – present; Mr. Derek Varney – present; Mr. Mike Kimbler – present. All the Council members were at their respective residences with the exception of Mrs. Wiley who was at the Government Center.

**APPROVAL OF MINUTES**

Mayor Kirk called for a motion to approve the minutes of the April 13, 2020 meeting. Motion made by Mr. Richardson; seconded by Mr. Flaherty. Voting as follows: Mr. Varney – yes; Mrs. Wiley – yes; Mr. Richardson – yes; Mr. Flaherty – yes; Mr. Kramer – yes; Mr. Kimbler – yes.

**ORDINANCES**

**First Readings**

Ms. Boumis read Ordinance 15 – 20: An Ordinance Authorizing The Mayor To Execute Necessary Conveyance Documentation To Acquire Approximately 0.46 Acres, More Or Less, Fee Simple Interest, In Parcel 153-000071 And 0.24 Acres, More Or Less, Fee Simple Interest At The Property Located At 1816 Arcadia Avenue.

**Second Readings**

Ms. Boumis read Ordinance 13 – 20: An Ordinance Approving The Recodification, Editing And Inclusion Of Certain Ordinances As Parts Of The Various Component Codes Of The Codified Ordinances Of Obetz And Declaring An Emergency.

**Third Readings**

Ms. Boumis read Ordinance 10 – 20: An Ordinance Authorizing The Village Administrator to Enter Into An Agreement with Premier 365 To Construct A Sports Complex And Declaring An Emergency. Mr. Davisson stated that in light of the current situation, construction of the facility will be delayed. Mayor Kirk called for a motion to table Ordinance 10 – 20. Motion made by Mrs. Wiley; seconded by Mr. Richardson. Voting as follows: Mr. Varney – yes; Mrs. Wiley – yes; Mr. Richardson – yes; Mr. Flaherty – yes; Mr. Kramer – yes; Mr. Kimbler – yes.

**Emergencies**

Ms. Boumis read Ordinance 16 – 20: An Ordinance To Approve And Authorize The Village Administrator To Enter Into An Agreement With Media Promotions Enterprises For Entertainment At The 2020 Obetz Zucchini Festival And Declaring An Emergency. Mr. Davisson discussed the Ordinance. He stated that

entertainment services for ZucchiniFest are subcontracted to MPE. The contract has been enhanced to protect the taxpayer and minimize risk to the Village in case the festival is canceled. Mayor Kirk called for a motion to suspend the rules regarding the adoption of Ordinance 16 – 20. Motion made by Mr. Richardson; seconded by Mrs. Wiley. Voting as follows: Mr. Varney – yes; Mrs. Wiley – yes; Mr. Richardson – yes; Mr. Flaherty – yes; Mr. Kramer – yes; Mr. Kimbler – yes. Mayor Kirk called for a motion to adopt Ordinance 16 – 20. **NEW BUSINESS**




**REMARKS FROM THE AUDIENCE**
