# **MAYOR'S REPORT**

Ms. Boumis read Ordinance 15-20: An Ordinance Authorizing The Mayor To Execute Necessary Conveyance Documentation To Acquire Approximately 0.46 Acres, More Or Less, Fee Simple Interest, In Parcel 153-000071 And 0.24 Acres, More Or Less, Fee Simple Interest At The Property Located At 1816 Arcadia Avenue. Ms. Boumis stated that the Franklin County Land Bank is taking possession of the properties; demolishing the structures; and then deeding them to the Village at no cost.

Ms. Boumis read Ordinance 13-20: An Ordinance Approving The Recodification, Editing And Inclusion Of Certain Ordinances As Parts Of The Various Component Codes Of The Codified Ordinances Of Obetz And Declaring An Emergency.
