ORDINANCE: 48 – 20

PASSED: October 13, 2020

AN ORDINANCE APPROVING THE MAYOR’S APPOINTMENT OF EUGENE L. HOLLINS AS DIRECTOR OF LAW OF THE VILLAGE OF OBETZ AND AUTHORIZING THE MAYOR TO EXECUTE AN EMPLOYMENT AGREEMENT, AND DECLARING AN EMERGENCY

WHEREAS, in 2013, pursuant to Section 6.02(B) of the Charter for the Village of Obetz, this Council created the Department of Law; and,

WHEREAS, pursuant to Section 6.02(B) of the Charter, this Council is required to approve the Mayor’s appointment of the Director of Law; and,

WHEREAS, the Mayor has appointed Eugene L. Hollins to serve as the Director of Law and Mr. Hollins is appreciative of the appointment and desirous of serving the Village and its residents, elected officials and administrative staff as the full-time Director of Law;

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF OBETZ, OHIO, THAT:

Section 1. Pursuant to Section 6.02(B) of the Charter of the Village of Obetz, this Council hereby approves the appointment of Eugene L. Hollins as Director of Law.

Section 2. This Council hereby authorizes the Mayor to execute an Employment Agreement with Mr. Hollins, in a form substantially similar to the agreement on file with the office of the Clerk, to confirm the terms and conditions of Mr. Hollins’ appointment as Law Director.

Section 3. This Ordinance is declared an emergency measure, the immediate passage of which is necessary for the preservation of the health, safety and welfare of the citizens of the Village of Obetz, such emergency arising from the immediate need to appoint a Law Director for the Village of Obetz; WHEREFORE, this Ordinance shall take effect and be in force immediately upon its passage.
