ORDINANCE: 50 – 20

PASSED: October 13, 2020

AN ORDINANCE TO APPROVE CHANGES TO THE 2020 APPROPRIATIONS FOR THE CURRENT EXPENSES AND OTHER EXPENDITURES OF THE VILLAGE OF OBETZ

WHEREAS, Ordinance Number 57-19 approved the 2020 appropriations for the current expenses and other expenditures of the Village; and,

WHEREAS, additional Coronavirus Relief Funding was allocated to the Village of Obetz; and,
