#### **MAYOR'S REPORT**

Mayor Kirk presented a list of dates for Village sponsored events. She also stated that a Council planning session is planned for February 20<sup>th</sup> from 9:00 AM to 1:00 PM. This is a brainstorming meeting. Nothing is off the table.

# **COMMITTEE REPORTS**

Mr. Varney stated that he is working on the Committee assignments. Mr. Kramer stated Hamilton Local Schools is going to a hybrid system again. Mrs. Wiley stated she has been asked if the lights around the church can stay lit. She then stated she has been helping an elderly resident get set up with Franklin County's Senior Options program. She has also been working with the resident to get other private services. She stated that she has learned a lot during her time helping the resident and she would be happy to share her research with the Village. She then stated she has gotten calls from residents regarding stray cats. She stated she is willing to work with volunteers interested in helping stray cats. She wanted to know what she can do as a Council Member. Mr. Davisson stated that as a private citizen she can help in any way she wants. The Village can provide space for meetings if residents want to meet to discuss issues and solutions. It is harder for the Village to give money to non-profits.

#### **ADMINISTRATION'S REPORT**

Mike Confer, Police Chief — Chief Confer stated calls for service have slowed down. There were 767 calls for service since the last meeting. The department's new policies will be reviewed by the State of Ohio this week. Chief Confer further stated that Officer Davis and Officer Burris caught an individual that was stealing from job sites in Butler Farms.

Hamilton Township Fire Department – Wade Edwards was in attendance. He stated he is the acting Chief. He discussed the community paramedic program and its success. He further stated he has been working closely with the Central Ohio Area Agency on Aging as a part of the program. The Agency has a lot of resources. He just needs help getting the word out about the program. A new fire chief will be selected by the end of the month.

Gene Hollins, Esq., Law Director – Mr. Hollins stated an executive session was needed.

Stacey Boumis, Community Services Director - No report.

Rod Davisson, Esq., Administrator – Mr. Davisson reviewed each event date presented by the Mayor. Council voiced no objections to the proposed event dates. Mr. Davisson then discussed the Greenfield Estates Mobile Home Park. The Park is on a master water meter meaning the Park gets one bill. It is considered a commercial account. The property manager of the Park asked Obetz if the Park would be getting a utility holiday. Mayor Kirk, Mr. Davisson, and Council discussed the request. It was determined that the utility holiday was not a commercial program and the Park would not be getting the holiday. Mr. Davisson discussed opening the Obetz Athletic Club. The new equipment arrives February 4<sup>th</sup>. The gym should be open to the public between February 8<sup>th</sup> to 10<sup>th</sup>. The golf league will also start.
