MAYOR'S REPORT

Mayor Kirk stated the Obetz Athletic Club opened today and sign-ups are open for the indoor golf league. The ice rink is also open. Mayor Kirk and Council discussed baseball and softball fees. Mayor Kirk stated she wants to waive fees for the season since these sports were canceled last year. In addition, football fees were waived. There were no objections to waiving fees for kids living in the Hamilton or Groveport School Districts or for kids whose parents work in Obetz.

COMMITTEE REPORTS

Mr. Varney discussed Council Committee assignments. He stated that he kept the Committee chairs the same and only made a few modifications. Since there was not a lot of activity last year, this gives individuals another year on these committees. He further stated a lot of stuff is going to be happening at the Fortress this year.

Mr. Richardson stated the Street Department has done a good job with snow removal.

Mr. Kramer reported that the Hamilton Township Fire Department has a new fire chief.

Mrs. Wiley stated there is a lot of litter around the Village. Mr. Davisson, Mayor Kirk and Council discussed this issue. Mr. Davisson stated that picking up trash around the Village takes a lot of time.

ADMINISTRATION'S REPORT

Mike Confer, Police Chief — Chief Confer stated there were 836 dispatched calls for service since the last meeting and 6 crashes due to weather.

Hamilton Township Fire Department – Wade Edwards was in attendance. There is no new Fire Department business.

Gene Hollins, Esq., Law Director – Mr. Hollins stated an executive session was needed.
