ORDINANCE: 13 – 21

PASSED: March 22, 2021

AN ORDINANCE TO APPROVE CHANGES TO THE 2021 APPROPRIATIONS FOR THE CURRENT EXPENSES AND OTHER EXPENDITURES OF THE VILLAGE OF OBETZ, AND DECLARING AN EMERGENCY

WHEREAS, Ordinance Number 56 – 20 approved the 2021 appropriations for the current expenses and other expenditures of the Village; and,

WHEREAS, changes to the 2021 appropriations are required for the payment of certain obligations and a reduction of appropriations is needed to meet statutory requirements or to better account for appropriation needs.

This Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, and safety of the Village and for the further reason that the exigencies of payroll reporting and implementation of employee raises for calendar year 2021 necessitate adoption of legislation at the earliest possible date; WHEREFORE, this Ordinance shall take effect and be in force from and after its passage.
