ORDINANCE: 25 – 21

**AN ORDINANCE TO APPROVE CHANGES TO THE 2021 APPROPRIATIONS FOR THE CURRENT EXPENSES AND OTHER EXPENDITURES OF THE VILLAGE OF OBETZ**

**WHEREAS**, Ordinance Number 56 – 20 approved the 2021 appropriations for the current expenses and other expenditures of the Village; and,
