ORDINANCE: 45 – 21

PASSED: November 8, 2021

AN ORDINANCE TO APPROVE CHANGES TO THE 2021 APPROPRIATIONS FOR THE CURRENT EXPENSES AND OTHER EXPENDITURES OF THE VILLAGE OF OBETZ

WHEREAS, Ordinance Number 56 – 20 approved the 2021 appropriations for the current expenses and other expenditures of the Village; and,

WHEREAS, changes to the 2021 appropriations are required for the payment of certain obligations and a reduction of appropriations is needed to meet statutory requirements or to better account for appropriation needs.
