REGULAR MEETING OF NOVEMBER 8, 2021

First Readings

Second Readings

Ms. Boumis read Ordinance 43 – 21: An Ordinance To Approve The 2022 Permanent Appropriations Of All Funds For The Current Expenses And Other Expenditures Of The Village Of Obetz. No discussion.

Third Readings

Ms. Boumis read Ordinance 39 – 21: An Ordinance Approving The Recodification, Editing And Inclusion Of Certain Ordinances As Parts Of The Various Component Codes Of The Codified Ordinances Of Obetz And Declaring An Emergency. Mr. Davisson discussed the Ordinance. He stated this is done yearly. The permanent ordinances that make laws are put into a book; they are codified.
