Ms. Boumis read Ordinance 33 – 21: An Ordinance To Accept The Annexation Of 93.8 +/- Acres From Hamilton Township To The Village Of Obetz, Designate The Zoning As Planned Residential District, And To Approve The Preliminary Development Plan. Mayor Kirk stated there will be discussion at a future meeting. The Planning and Zoning Commission is still reviewing the plan.

Ms. Boumis read Ordinance 35 – 21: An Ordinance Amending Section 305.02 Of The Codified Ordinances Of The Village Of Obetz Related To Stop Signs On Orchard Lane And Declaring An Emergency. Mayor Kirk discussed the Ordinance asked Council if they wanted to wait another six weeks to adopt the Ordinance or proceed tonight. MAYOR'S REPORT

Mayor Kirk stated Obetz is preparing for Halloween. The Village's annual Halloween party will be on Friday, October 29th at the Fortress. Trick or Treat will be on October 28th from 6:00 to 8:00 PM. The splashpad is closed and the transition into an ice-skating rink will begin soon. Mr. Flaherty stated he would like the backer boards redone. Mayor Kirk stated that is already planned.

COMMITTEE REPORTS

Mr. Kimbler, Parks and Programming – Mr. Kimbler stated all Obetz teams are doing well in the Youth Mid State League.

Mr. Varney, Fortress Obetz, Regional Recreation and Events – Mr. Varney stated the last bike night was well attended. Bands Across America was also a huge success and they plan on returning to the

Fortress. The Buddy Walk is this weekend. Ohio State Rugby is playing at the Fortress this fall as well as Bishop Ready football. OHSAA cross country meets are in early November. Steve Adams' crew is doing a good job at the Fortress and continues to stay busy.

Mr. Richardson, Public Works and Safety – No new issues to report.

Mr. Flaherty, Development – Mr. Flaherty stated a lot of stuff is happening.

Mr. Kramer, Intergovernmental Outreach – Mr. Kramer stated Hamilton Township Trustee Chris Hann appreciated the flowers sent by Obetz to his wife's funeral service.

Mrs. Wiley, Neighborhood Preservation and Beautification – Mrs. Wiley stated there is a light post on Bridlewood Court with peeling paint. There are also a lot of bees by a fire hydrant near the intersection of Ethel Road/Rodger Road.

ADMINISTRATION'S REPORT

Mike Confer, Police Chief — Chief Confer stated there is a grant for body cameras. He then stated he won't know what is covered in the grant until Obetz applies. Mayor Kirk stated she wants the Police Department to apply for the grant and see what is available. Council concurred.

Martin Hafey, Fire Chief, Hamilton Township — Chief Hafey stated there were 116 runs in Obetz proper last month. The Department attended the Zucchinifest and provided aid to 22 people. Approximately 850 kids went through the spray house. He then stated the Community Paramedic program is expanding. Several individuals are in training now. On October 3 through 5 the Department will be at Hamilton Elementary School doing activities with the kids. Four new part-timers were recently hired.

Gene Hollins, Esq., Law Director - No report.

Stacey Boumis, Community Services Director – No report.

E. Rod Davisson, Esq., Administrator – Mr. Davisson stated the Administration building and Community Center are closed this week due to COVID concerns. He discussed the Village's COVID work plan. Due to the office closure, there will be no late fees on water bills.

REMARKS FROM THE AUDIENCE

Chris Herren, a resident, addressed Council. He inquired about the speed limit signs on Howard Road. He stated the signs were knocked down months ago and have not been replaced. Speeding on Howard Road is ridiculous. Mayor Kirk directed Chief Confer to put the black box back up on Howard Road. Mr.

Herren continued to discuss traffic on Howard Road. He then stated that traffic from big events in Obetz should not be routed through the neighborhoods. He then stated there is nothing here for kids to do. All activities are for adults. He complained about the park on Howard Road. Mayor Kirk stated the park is getting redone. Mr. Davisson discussed planned road and park improvements. He further stated Obetz is working hard to minimize the impact of Fortress events on the neighborhoods. Mayor Kirk asked Mr. Herren what type of activities he would like to see for kids. He stated he was upset that a basketball court was not getting re-installed at the park on Howard Road. He then stated he would like to see a swimming pool. Mayor Kirk asked Mr. Herren to get back to her with additional activities he would like to see for kids.

Jerry Benson reminded everyone about the October 13th meeting of The Historians.

Andy Borders asked if any progress has been made with Mason's. Mr. Davisson stated the Ohio EPA has issued 10 citations with no consequences. He then stated right of way mowing has not been done and when the County cleaned up by the bridge, everything was left in the road.
