



ORDINANCE: 36 – 22

PASSED: June 13, 2022

**AN ORDINANCE AUTHORIZING THE DIRECTOR OF FINANCE TO MAKE PAYMENT ON CONTRACTS WITH IGS VENTURES, INC. AND SITEZEUS SERVICES, LLC AND DECLARING AN EMERGENCY**

**WHEREAS**, IGS Ventures, Inc. provided natural gas, and SiteZeus Services, LLC provides economic development software to the City of Obetz; and,

**WHEREAS**, after these services were rendered, the City received invoices for which a purchase order, with a prior certification of availability of funds by the Director of Finance attached, had not been obtained, or was obtained but without sufficient balance; and,

**WHEREAS**, Section 5705.41 (D)(1) of the Ohio Revised Code provides that in certain circumstances a subdivision may authorize payment on a contract executed without prior certification by the subdivision's Director of Finance; and,

**WHEREAS**, the City Council now has before it a certificate from the Director of Finance certifying there was at the time of the making of that contract and at the time of the execution of such certificate a sufficient sum appropriated for the purpose of such contract and in the treasury or in process of collection to the credit of an appropriate fund free from any encumbrances (a "then and now certificate"); and,

**WHEREAS**, less than thirty days have passed since the City Council's receipt of the certificate from the Director of Finance; and,

**WHEREAS**, the City Council desires to satisfy the obligations of the contracts;

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF OBETZ, OHIO, THAT:**

Section 1. City Council hereby acknowledges receipt of "then and now certificates" from the Director of Finance and authorizes and directs the Director of Finance to make payment not to exceed the amount of \$127,613.05 payable to IGS Ventures, Inc., and payment not to exceed \$29,500 to SiteZeus Services, LLC.



Section 2. This Ordinance is hereby declared to be an emergency measure, necessary for the preservation of the public health, safety and welfare, such emergency arising from the need to comply with statutory timelines concerning "then and now certificates"; WHEREFORE, this Ordinance shall take effect and be in force from and after its passage.
