SPECIAL MEETING OF JUNE 16, 2022

A special meeting was held in Council Chambers at the Government Center, 4175 Alum Creek Drive, on Thursday, June 16th at 5:00 PM with Mayor Angela M. Kirk presiding.

ROLL CALL

Ms. Boumis called the roll. Mr. Michael Flaherty – present; Mr. Robert Kramer – absent; Mr. Guiles Richardson – present; Mr. Todd Gibbs – present; Mr. Derek Varney – present; Mr. Mike Kimbler – present. Mayor Kirk called for a motion to excuse Mr. Kramer. Motion made by Mr. Flaherty; seconded by Mr. Richardson. Voting as follows: Mr. Varney – yes; Mr. Richardson – yes; Mr. Flaherty – yes; Mr. Gibbs – yes; Mr. Kimbler – yes. Motion carried.


ORDINANCES

Ms. Boumis read Ordinance 34 – 22: Mayor Kirk read Ordinance 38 – 21: An Ordinance Determining Sufficiency Of The Petition For Establishment Of The Buckstone Community Authority As A New Community Authority And Setting A Date For Public Hearing Under Chapter 349 Of The Ohio Revised Code; And Declaring An Emergency. Mr. Davisson discussed the Ordinance. He stated the next steps are to create the Buckstone New Community Authority. Taxes will be redirected to the New Community Authority from other political subdivisions. All property owners have signed the petition requesting the creation of the New Community Authority.


Mayor Kirk asked if there were any questions. Mr. Donnie Cowell Jr. begin asking about layoffs. Mr. Davisson stated that this meeting is to discuss Ordinance 34 – 22 only. Mr. Cowell continued to read a prepared statement regarding layoffs. Mr. Hollins stated that the public is not permitted to speak about anything other than Ordinance 34 – 22. Mr. Davisson stated the public can attend the July 27th meeting for open discussion. Ms. Jennifer Kyrie asked why a special meeting was held. Mr. Hollins stated that the land owners met Tuesday to finalize the petition. The Ordinance could not be passed until all land owners signed the petition. Thursday was the earliest the City could have the meeting. Mr. Andy Borders asked what meeting is July 25th? Mr. Hollins stated that is the public hearing on the creation of the New Community Authority. Mr. Borders then stated meetings should be held at 6:00 PM rather than 5:00 PM to make it easier for the public. Mayor Kirk stated Mr. Richardson is officiating a funeral this evening and it was necessary to have the meeting at 5:00 PM.

Mayor Kirk called for a motion to adjourn. Motion made by Mr. Flaherty; seconded by Mr. Gibbs. All ayes. Council adjourned at 5:10 PM.
