ORDINANCE: 30 – 22

PASSED: July 11, 2022

**AN ORDINANCE TO ADOPT THE TAX BUDGET FOR THE CITY OF OBETZ, OHIO FOR THE FISCAL YEAR BEGINNING JANUARY 1, 2023 AND TO SUBMIT THE SAME TO THE FRANKLIN COUNTY BUDGET COMMISSION AND DECLARING AN EMERGENCY**

**WHEREAS**, the 2023 Tax Budget has been prepared as required by Section 5705.28 of the Ohio Revised Code; and,

**WHEREAS**, the Ohio Revised Code requires that the Tax Budget be adopted by July 15<sup>th</sup> and transmitted to the Franklin County Budget Commission on or before July 20<sup>th</sup>; and,

**WHEREAS**, said Tax Budget has been on file with the Finance Director of the City and has been available for public inspection as required by ORC Section 5705.30; and,

**WHEREAS**, a public hearing was held on July 11<sup>th</sup> during the regularly scheduled Council meeting.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF OBETZ, OHIO, THAT:**

Section 1. The Tax Budget for the City of Obetz, Ohio for the fiscal year beginning January 1, 2023, a copy of which is on file with the Clerk and incorporated by reference, be and is hereby adopted by the Council of the City of Obetz, Ohio.

Section 2. The Finance Director be and hereby is authorized and directed to certify a copy of said budget and a copy of this Ordinance and to transmit the same to the Franklin County Budget Commission on or before July 20<sup>th</sup>.

Section 3. This Ordinance is hereby declared to be an emergency measure necessary for the preservation of the public peace, health, welfare, and safety and for the further reason that there exists the immediate necessity to certify a copy of the Tax Budget to the Franklin County Commissioners before July 20<sup>th</sup>; WHEREFORE, this Ordinance shall take effect and be in force from and after its passage.
