#### Second Readings

Ms. Boumis read Ordinance 40 – 22: An Ordinance Finding That The Creation Of The Southwest Area New Community Authority, A New Community Authority Pursuant To Chapter 349 Of The Ohio Revised Code, Will Be Conducive To The Public Health, Safety, Convenience And Welfare And Is Intended To Result In The Development Of A New Community; Declaring The Authority To Be Organized And A Body Politic And Corporate; Defining The Boundary Of The Authority's New Community District; Providing The Method Of Selecting That Authority's Board Of Trustees; Appointing Four Members To That Board; Fixing The Surety For Those Trustees' Bonds; Prohibiting The Dissolution Of The Authority Without Consent; And Authorizing Any Other Related Authorizations And Actions; And Declaring An Emergency.

Mayor Kirk opened the public hearing. Mr. Davisson stated this ordinance is another step to create Buckstone. The New Community Authority (NCA) is a vehicle for collecting tax money that can be used to pay for infrastructure in the area. The NCA is managed by a separate board appointed by Council and the developers. No questions. Mayor Kirk closed the public hearing.

Ms. Boumis read Ordinance 41 – 22: An Ordinance Amending Section III - Vacation Of The Employee Handbook Related To The Accrual Of Vacation Hours And Declaring An Emergency. Mr. Davisson stated there is a three-year limit on the accrual of vacation. The ordinance proposes to increase that to five years. Mr. Kramer asked how much vacation could be used at once. Mr. Davisson stated most people don't take more than two weeks at once and all vacation requires approval. Mayor Kirk called for a motion to suspend the rules regarding the adoption of Ordinance 41 – 22. Motion made by Mr. Flaherty; seconded by Mr. Gibbs.
