ORDINANCE: 47 – 22

PASSED: October 11, 2022

AN ORDINANCE TO APPROVE CHANGES TO THE 2022 APPROPRIATIONS FOR THE CURRENT EXPENSES AND OTHER EXPENDITURES OF THE CITY OF OBETZ

WHEREAS, Ordinance Number 43 – 21 approved the 2022 appropriations for the current expenses and other expenditures of the City; and,

WHEREAS, changes to the 2022 appropriations are required for the payment of certain obligations and a reduction of appropriations is needed to meet statutory requirements or to better account for appropriation needs.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF OBETZ, OHIO, THAT:

Section 1. The following funds are hereby appropriated/(unappropriated):

Section 2. The Finance Director shall certify these changes to appropriations with the Franklin County Budget Commission.

Section 3. The Finance Director and City Administrator are hereby authorized to enter into agreements, in a form approved by the Director of Law, resolving any potential claims for refunds from taxpayers, including reimbursement terms and procedures and/or tax credits grants to such taxpayers, subject only to appropriation of funds necessary to perform such agreements by City Council.

Section 3. This Ordinance shall take effect and be in force from and after the earliest period allowed by law.
