AN ORDINANCE TO APPROVE CHANGES TO THE 2022 APPROPRIATIONS FOR THE CURRENT EXPENSES AND OTHER EXPENDITURES OF THE CITY OF OBETZ

<u>Section 3.</u> City Council hereby ratifies and approves the Memorandum of Understanding between the City of Obetz, Ohio and Fraternal Order of Police, Capital City Lodge No. 9, a copy of which is on file in the office of the Clerk of Council, providing for, among other things, certain backpay and longevity pay payments for 2022, the appropriation for which are included in the ordinance.

<u>Section 4.</u> City Council hereby authorizes the Mayor to enter into addenda with any employees governed by employment agreements to conform such agreements to the comprehensive changes to wages, hours and other terms and conditions of employment being implemented for all other Obetz employees, in a form acceptable to the Mayor.

<u>Section 5.</u> This Ordinance shall take effect and be in force from and after the earliest period allowed by law.
