REGULAR MEETING OF JUNE 12, 2023

The regular meeting was held in Council Chambers at the Government Center, 4175 Alum Creek Drive, on Monday, June 12, 2023 at 6:00 PM with Mayor Angela M. Kirk presiding.

Ms. Boumis read the title of Ordinance 15-23: An Ordinance Approving The City Of Obetz Annual Conversion Plan Which Allows Employees To Convert Vacation And Sick Time To Cash In Accordance With The Ohio Public Employees Retirement System (OPERS) Specifications.

Ms. Boumis read the title of Ordinance 18 – 23: An Ordinance To Express Gratitude And Acknowledge The Generous Donation Of Light Fixtures By Mr. Adam J Rajczyk To The City Of Obetz, Ohio, And To Accept This Donation On Behalf Of The City.
