REGULAR MEETING OF AUGUST 14, 2023

The regular meeting was held in Council Chambers at the Government Center, 4175 Alum Creek Drive, on Monday, August 14, 2023 at 6:00 PM with Mayor Angela M. Kirk presiding.

ROLL CALL

Ms. Boumis called the roll. Also present were Michael Confer, Police Chief; Gene Hollins, Esq., Law Director; Stacey Boumis, Community Services Director, and Rod Davisson, Esq., Administrator.

PROCLAMATIONS AND PRESENTATIONS

State of the City

Mr. Davisson stated the directors were present for the annual State of the City address. The numbers in the report are from 2022. Mr. Davisson then presented the first few slides which were an introduction; letter from Mayor Kirk; introduction of the elected officials; and introduction of the City Administration, headed by Rod Davisson as the City Administrator. Mr. Michael Corbitt, Deputy City Administrator/City Engineer presented next. He discussed the numerous projects his office managed including Groveport Road/Bixby Road improvements; the Rathmell Road waterline extension; various demolition and pavement projects; Orchard Lane storm sewer improvements; and Buckstone preliminary design. Mr. Todd Garwick, Utilities Director, presented next. He discussed the Cityworks management system; Bluebeam software; asset management; various development projects; and right of way permits. Mr. Cramblit was absent, so Mr. Davisson presented the financial report/financial strategy. He stated Mr. Cramblit manages the City's investments based on the adopted investment policy. Mr. Derek Duncan, Human Resources Director, presented next. He discussed collective bargaining; the City's biannual first aid training; changes to the City's work week; and the new physical/mental wellness time program. Ms. Stacey Boumis, Community Services Director, presented next. She discussed the Planning and Zoning Commission; development projects; housing growth; code enforcement; and Zucchinifest. Mr. Davisson presented economic development achievements focusing on Buckstone and the East End Partnership. Chief Michael Confer stated there was a reduction in crime rates; body cameras were introduced; mental health resources were expanded; and traffic safety initiatives were enhanced. Ms. Kerri Duffy, Parks and Recreation Director, discussed the numerous 2022 events and programs as well as the park improvements undertaken. Mr. Ben Swauger was absent. Ms. Duffy provided details on the Obetz Athletic Club. In 2022, there were

36,191 total check-ins. She then discussed the golf simulators; personal training; and other activities at the Athletic Club. Ms. Mel Ross, Obetz Community Center Operations Manager, discussed the new senior activities; critical services offered; and the interns who worked at the Community Center. Mr. Jacob Gifford, Youth Sports Coordinator, discussed the various sports offered. He stated he wants to add fall baseball and softball. Mr. Steve Adams, Director of Economic Development and Promotions, discussed events at Fortress Obetz including the creation of Full Throttle Thursdays. LeAnna Moore, Multimedia Communications Specialist, discussed the various digital media platforms used by the City as well as engagement numbers. Stacey Boumis, Council Clerk, shared data related to meetings held by City Council. Jess Griffith, Grounds Superintendent/Deputy Safety Director, discussed the transition to Davey Tree for Tim Ross, Facilities grounds management as well as special projects in his department. Superintendent, discussed the projects in his department including the replacement of roof top units at the Administration building; remodeling projects; and upgrades to the faucets at the Fortress. Kyle Ingland, Service Department Superintendent, discussed the various projects undertaken in his department including installation of the Christmas tree; litter and snow control; intern training; street maintenance; replacement of light poles; and assisting other departments as needed. Bill Baker, Research and Development Superintendent, discussed the various projects in his department including the installation of the sand volleyball court; construction of the Fortress storage barn; park upgrades; and Mayor's Court upgrades. Mr. Davisson recognized Mr. Marty Ryan and Mr. Gene Hollins who were also in attendance. Mayor Kirk thanked the staff who attended.
