REGULAR MEETING OF DECEMBER 11, 2023

The regular meeting was held in Council Chambers at the Government Center, 4175 Alum Creek Drive, on Monday, December 11, 2023 at 6:00 PM with Mayor Angela M. Kirk presiding.

ROLL CALL

Ms. Boumis called the roll. Mr. Michael Flaherty – present; Mr. Robert Kramer – present; Mr. Guiles Richardson – present; Mr. Derek Varney – present; Mr. Mike Kimbler – present; Mr. Todd Gibbs – present. Also present were Mike Confer, Police Chief; Gene Hollins, Esq., Law Director; Stacey Boumis, Community Services Director, and Rod Davisson, Esq., City Administrator.

First Reading

Second Reading

Ms. Boumis read Ordinance 50 - 23: An Ordinance To Approve The 2024 Permanent Appropriations Of All Funds For The Current Expenses And Other Expenditures Of The City Of Obetz. Mr. Davisson discussed the Ordinance. Mr. Davisson stated there are 679 individual line items in the budget. He discussed appropriations versus expenses. He reviewed various parts of the budget. Cities need to appropriate as if everything is going to happen. There is a \$9 million dollar carryover from 2023. Approximately \$19.9 million dollars has been appropriated. The budget includes several new positions. The number one position on Mr. Davisson's list is a public information officer. Other positions include one to two new police officers; part time help at the Community Center; another employee in Grounds to replace Jess Griffith since he is transitioning to the grants work; and a replacement in the finance department once Mark Daubenmier retires. In January, Council will need to decide what capital projects it wants to undertake. Utility fund adjustments are also needed this year. Rates have not increased in 13 years. Mr. Davisson showed how he tracks the budget over time. He stated Council has access to his spreadsheet. Mayor Kirk called for a motion to suspend the rules regarding the adoption of Ordinance 50 - 23. Motion made by Mr. Gibbs; seconded by Mr. Kimbler. Ms. Boumis read Ordinance 51 – 23: An Ordinance To Amend Chapter 182 Of The Obetz Codified Ordinances To Update The City's Municipal Income Tax Code As Required By State Law, And To Declare An Emergency. Mr. Hollins discussed the Ordinance. He stated the State of Ohio has mandated changes to the City's income tax code. He reviewed the changes. Individuals under 18 are excluded from paying State income tax. There is now a cap on late filing penalties. The deadline for business filings has also been changed. Council discussed the changes and the impact to the City of Obetz. Mayor Kirk called for a motion to suspend the rules regarding the adoption of Ordinance 51 – 23. Ms. Boumis discussed the Hazard Mitigation Plan. She stated she participated in the update. Adoption of the Plan is required by law. It opens the City up to grants related to the mitigation of hazards. Mayor Kirk called for a motion to suspend the rules regarding the adoption of Ordinance 56 – 23. MAYOR'S REPORT

Mayor Kirk stated the Christmas Kick-Off went well. Staff worked hard on the event. She thanked Mr. Varney for playing the role of Santa. The event had great turn-out. The Santa ride through the neighborhoods is Saturday. Holiday lights judging is tomorrow.

ADMINISTRATION'S REPORT

Mike Confer, Police Chief – Chief Confer stated there was a speed box installed on Greenup Drive. It recorded speeds for 880 cars. The highest speed was 29 mph. The speed box was then installed on Lauren Fields Drive. It recorded 2311 cars. There were 13 speeders.

Eugene Hollins, Esq., Law Director - Mr. Hollins discussed the Sheetz liquor permit. He stated there is a request for a C-2 at the new location. It is for wine and wine coolers. Council had no objection to that. The Toy Road location is for a D-1 permit to allow spiked slushies. Gene explained that there are a limited number of licenses available in Obetz. There is 1-D-1; 3-D-2s; and 2-D-3s. Council stated they wanted to preserve licenses for bars and restaurants.

Rod Davisson, Esq., City Administrator – Mr. Davisson stated he is excited about next year and getting to do some cool projects. He is happy with the directors and the current employees. He stated he has a meeting coming up with ODOT. He then discussed the Zulily closure and utility upgrades.
