ORDINANCE: <u>09 – 24</u>

AN ORDINANCE ACCEPTING EASEMENTS FOR OFF-SITE INFRASTRUCTURE IMPROVEMENTS RELATED TO BUCKSTONE BEND SECTION 3 PHASE B, AND DECLARING AN EMERGENCY			
WHEREAS, off-site public infrastructure improvements were necessary for Buckstone Bend Section 3, Phase B; and,			
WHEREAS, the public infrastructure improvements have been completed and inspected, and it is necessary and appropriate to accept easements for these improvements in order that they may be dedicated to public use; and,			
WHEREAS, the Grantor of the easements is Real Estate Prophets, LLC.			
NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF OBETZ, OHIO THAT:			
<u>Section 1</u> . The Drainage Easements are hereby accepted and approved, and the Mayor is authorized to execute the same and arrange for recording with the Franklin County Recorder's Office.			
<u>Section 2.</u> The General Utility Easement is hereby accepted and approved, and the Mayor is authorized to execute the same and arrange for recording with the Franklin County Recorder's Office.			
<u>Section 3.</u> The Temporary Access Easement is hereby accepted and approved, and the Mayor is authorized to execute the same and arrange for recording with the Franklin County Recorder's Office.			
<u>Section 4.</u> This Ordinance is hereby declared to be an emergency measure immediately necessary for the preservation of the public peace, health, and safety of this municipality and for the further reason that the easements need to be accepted prior to acceptance of the final plat for this phase; WHEREFORE, this Ordinance shall take effect and be in force immediately upon passage by Council.
