Second Readings

Ms. Boumis read the title of Ordinance 07 - 24: An Ordinance Approving The Final Plat For Section 3 Phase B Of The Buckstone Bend Subdivision.

Ms. Boumis read the title of Ordinance 10-24: An Ordinance Authorizing The Issuance Of Not To Exceed Five Million Two Hundred Thousand Dollars (\$5,200,000) Of General Obligation Limited Tax Taxable Notes In Anticipation Of The Issuance Of Bonds, In One Or More Series, For The Purpose Of Acquiring Land And Interests In Land Located In The City Of Obetz; Reimbursing The City For Any Moneys Advanced For Such Purposes; Authorizing A Purchase Agreement, If Necessary; And Declaring An Emergency.

Ms. Boumis read the title of Ordinance 11-24: An Ordinance Authorizing The Issuance Of Not To Exceed One Million Seven Hundred Thousand Dollars (\$1,700,000) Of General Obligation Limited Tax Tax-Exempt Notes In Anticipation Of The Issuance Of Bonds, In One Or More Series, For The Purpose Of Acquiring And Constructing Public Utility Improvements, Including But Not Limited To Any Necessary Road, Sidewalk, Landscaping And Related Improvements And Appurtenances Thereto; Acquiring Land And Interests In Land Located Necessary For Such

Improvements; And Declaring An Emergency.

Ms. Boumis read the title of Ordinance 12-24: An Ordinance Authorizing The Issuance Of Not To Exceed \$3,200,000 Of Special Obligation Nontax Revenue Taxable Notes In Anticipation Of The Issuance Of Bonds, In One Or More Series, For The Purpose Of Acquiring Land And Interests In Land And Any Existing Buildings And Facilities Upon Such Land For The Purpose Of Redevelopment, Constructing A New Building Or Buildings Or Other Facilities For Commercial Use, And All Necessary Improvements And Appurtenances Related Thereto; Authorizing A Purchase Agreement, If Necessary; And Authorizing All Other Actions Necessary In Connection With Such Land Acquisition, Construction And Improvements; And Declaring An Emergency.

Emergencies

Ms. Boumis read the title of Ordinance 13-24: An Ordinance To Establish The Buckstone Community Authority Fiduciary Fund, And Declaring An Emergency. Mr. Davisson discussed the Ordinance. He stated this is an accounting fund. Mr. Hollins stated the City has received its first payment from the apartments. Mayor Kirk called for a motion to suspend the rules regarding the adoption of Ordinance 13-24. Motion made by Mr. Richardson; seconded by Mr. Flaherty. Ms. Boumis read the title of Ordinance 14-24: An Ordinance Authorizing The Director Of Finance To Make Payment On A Contract With Environmental Systems Research Institute, Inc. And Declaring An Emergency. Mr. Davisson discussed the Ordinance. He stated this is the City's mapping software. He apologized for the then and now. Mayor Kirk called for a motion to suspend the rules regarding the adoption of Ordinance 14-24. Motion made by Mr. Richardson; seconded by Mr. Gibbs. Ms. Boumis read the title of Ordinance 15-24: An Ordinance To Provide For A Contracting Procedure For Construction Of A Commercial And Office Building, Renovation Of An Existing Building, And Miscellaneous Infrastructure Improvements, And Declaring An Emergency. Mr. Davisson discussed the Ordinance. He stated adopting this Ordinance waives competitive bidding and allows the City to enter into a design-build contract for construction of a new building and renovation of the existing building on the DeVuono's site. Design-build contracts are the most efficient way to build. This process allows the City to move quickly. Robertson Construction

will be the contractor. Mr. Varney stated design-build is a very accepted process. It is adaptable. The general contractor is still bidding out work to subcontractors to get the best price.

Mr. Davisson then stated the new building will be a shell. It will be approximately 10,000 square feet. He asked Council what uses they would like to see in the new building. Council members want: restaurant, pharmacy, eye doctor, optometrist, dentist, chiropractor, coffee shop, smoothie shop, game shop. Mr. Flaherty said the City needs everything.

Mr. Davisson then asked the members of the audience what they would like to see. Members of the audience would like restaurants, a bike shop, sports store, and a pharmacy. Mr. Davisson stated he is designing a resident survey. He is also designing a survey to get feedback on a new name for Lancaster Park.

Mayor Kirk called for a motion to suspend the rules regarding the adoption of Ordinance 15 – 24. Motion made by Mr. Flaherty; seconded by Mr. Kimbler. REMARKS FROM THE AUDIENCE

Jerry Benson addressed Council. He stated residents have been asking him to come to the meeting and speak on their behalf. More people are coming to the Community Center and this is wonderful. The staff does a great job. He asked why the property behind McDonald's hasn't been developed since it was sold. Mr. Davisson stated the City is in a partnership with Casto Development. The property has not been sold. The City has turned down numerous things. He listed some of the uses that the City has turned down. Mr. Flaherty stated the City is going to be picky about what goes there. Mr. Davisson further stated the City has been working with ODOT to obtain a right-in/right-out access. This has been turned down but the City is still working with ODOT on this. As pieces develop, the land is sold and the City recuperates its investment. This is a long-term play. Interest rates are killing projects.

Mr. Benson then stated he has been hammered about the design of Lancaster Park. The parking is too far away; it should be in the middle. Mr. Kimbler stated it is not safe to put the parking in the middle and make people walk through a parking area to get to the restrooms. Mr. Davisson stated all the paths in the park are accessible. Someone will always have to walk. Mr. Benson stated Lancaster Avenue could be cut-off. Mr. Davisson stated a roundabout is needed.

Mr. Borders asked if there was enough parking on the Collins property to accommodate parking. Mr. Davisson stated there was.
