ORDINANCE: 25 – 24

PASSED: May 28, 2024

AN ORDINANCE TO APPROVE CHANGES TO THE 2024 APPROPRIATIONS FOR THE CURRENT EXPENSES AND OTHER EXPENDITURES OF THE CITY OF OBETZ

WHEREAS, Ordinance Number 55 – 23 approved the 2024 appropriations for the current expenses and other expenditures of the City; and,
