REGULAR MEETING OF MAY 28, 2024

The regular meeting of May 28, 2024 was held at 6:10 PM in Council Chambers at the Government Center, 4175 Alum Creek Drive, with Mayor Angela M. Kirk presiding.

ORDINANCES

First Readings

Ms. Boumis read the title of Ordinance 26 – 24: An Ordinance To Adopt The Tax Budget For The City Of Obetz, Ohio For The Fiscal Year Beginning January 1, 2025 And To Submit The Same To The Franklin County Budget Commission And Declaring An Emergency.

Second Readings

Ms. Boumis read the title of Ordinance 21 – 24: An Ordinance To Establish The 2024 Capital Improvements Fund A (4913), And Declaring An Emergency. Mr. Davisson discussed Ordinance 21 – 21, Ordinance 22 – 24, and Ordinance 23 – 24. He stated these are the ordinances for note related borrowing. Projects include the improvements to Lancaster Park, undergrounding electric along Lancaster Avenue, constructing the incubator building, and purchasing the Younkin property. These ordinances need adopted tonight because the funds will be available prior to the next meeting. Council has already authorized the City to get the funds; this is just housekeeping to establish the accounts where the funds will be deposited. Third Readings

Ms. Boumis read the title of Ordinance 18 – 24: An Ordinance To Rezone Parcel Numbers 153-000285 And 153-000286, From General Commercial To Planned Commercial District, To Approve A Preliminary Development Plan And Text, And To Authorize The Administrator To Enter Into A Development Agreement. Mayor Kirk opened the public hearing. Ms. Boumis reviewed the Final Development Plan including the landscaping, building architecture and materials, and site layout. She stated there are three parcels. Two parcels are zoned general commercial and one is zoned planned commercial district. The rezoning affects the two parcels that are zoned general commercial; they will now be planned commercial like the other parcel. The Planning and Zoning Commission recommended approval. A member of the audience, name not given, asked if Maureen Boulevard would be widened. Mr. Davisson stated not as a part of this project. Mayor Kirk called for a motion to adopt Ordinance 18 – 24. Eugene Hollins, Esq., Law Director – Mr. Hollins congratulated Subway on receiving zoning approval and discussed the process moving forward. There will be vacant land after the Subway is built. Any additional development of the parcel will require Council approval.

Rod Davisson, Esq., City Administrator – Mr. Davisson stated Obetz is busy. A lot of projects are in the planning phase. Surveys are still running. The incubator building will be under roof by December and something should be open by summer 2025. Younkin closes in phases.
