ORDINANCE: 42 – 25

PASSED: August 11, 2025

**AN ORDINANCE TO EXTEND THE MORATORIUM ON THE ISSUANCE AND PROCESSING OF PERMITS ALLOWING RETAIL DISPENSARIES, CULTIVATORS, OR PROCESSORS OF ADULT USE MARIJUANA WITHIN THE CITY OF OBETZ, AND DECLARING AN EMERGENCY**

**WHEREAS**, Council adopted Ordinance No. 08-24 on March 25, 2024 to impose a moratorium on the issuance and processing of any permits for cultivators, processors, and retail dispensaries of adult use marijuana as defined in Sections 3780.01 through 3780.99 of the Ohio Revised Code; and,

**WHEREAS**, a moratorium until September 30, 2024 was established to provide sufficient time for state regulations to be adopted, amendments to state law to be adopted, and/or an opportunity for the Mayor, Council and City staff to study the foregoing and adopt legislation that provides for the orderly implementation of adult use cannabis in the City consistent with State laws and regulations; and,

**WHEREAS**, Council adopted Ordinance 42 – 24, thereby extending the moratorium until February 28, 2025; and,

**WHEREAS**, Council adopted Ordinance 13 – 25, thereby extending the moratorium until July 31, 2025; and,

**WHEREAS**, although a number of bills are pending in the Ohio General Assembly to make significant changes to the citizen-initiated adult cannabis use provisions of the Revised Code, the General Assembly has yet to adopt a proposed reform to the new law; and,

**WHEREAS**, based on the foregoing, Council desires to further extend the moratorium until March 1, 2026.

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF OBETZ, OHIO, THAT:**

Section 1. Section 4 of Ordinance 08-24 is amended by deleting the date "July 31, 2025" and replacing it with the date "March 1, 2026."

Section 2. This Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, property, health, safety and welfare in the City and for the usual daily operation of the City for the reasons set forth and defined in the preamble to this Ordinance; WHEREFORE, this Ordinance shall take effect and be in force immediately upon its adoption by Council.
