AN ORDINANCE AUTHORIZING THE SALE OF CERTAIN REAL PROPERTY OWNED BY THE CITY OF OBETZ TO GRAND COMMUNITIES, LLC AND DECLARING AN EMERGENCY

**WHEREAS**, Section 3.01 of the City Charter provides that this Council has the power to sell or otherwise convey interest in real property; and,

**WHEREAS**, Section 157.04(j) of the Codified Ordinances provides that this Council may authorize the purchase and sale of real property with or without public bidding, on such terms and for such value as Council, in the exercise of its discretion, may deem reasonable and in the best interest of the City; and,

WHEREAS, the City owns approximately one hundred four and eight-tenths (104.8 +/-) acres of real property located within the City, consisting of consisting of portions of Franklin County Auditor Parcel Numbers 152-001744-00, 152-001847-00, 152-001841-00, and 152-001749-00 (the "Property"), which this Council hereby finds and determines is not required by the City for its purposes; and,

**WHEREAS**, this Council recognizes that the continued growth and diversification of the City's housing stock is essential to supporting and sustaining local businesses, public facilities, and the economic vitality of the community; and,

**WHEREAS**, the residential development of the Property will compliment and support ongoing commercial growth in the Buckstone New Community District and thereby create or preserve employment opportunities, promote economic welfare, and improve the economic stability of the City; and,

**WHEREAS**, the sale of the Property for residential development is consistent with the City's comprehensive development policies and the powers granted to municipal corporations by Article XVIII of the Ohio Constitution;

## NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF OBETZ, OHIO THAT:

Section 1. City Council hereby authorizes and directs the City Administrator to enter into a Purchase and Sale Agreement that conveys the Property to Grand Communities LLC, a Kentucky limited liability company, for a purchase price of two million seven hundred ninety-two thousand nine hundred ten dollars (\$2,792,910.00), in accordance with the terms and conditions detailed in the Agreement, a copy of
