**AN ORDINANCE AUTHORIZING THE MAYOR OR ADMINISTRATOR TO ENTER INTO VARIOUS RECURRING CONTRACTS NECESSARY FOR THE CONTINUOUS OPERATION OF THE CITY AND DECLARING AN EMERGENCY**

**WHEREAS**, the City of Obetz annually enters into numerous contracts with other governmental entities and service providers for services necessary for the continuous operation of the City; and,

**WHEREAS**, the City desires to enter contracts with these same agencies and providers for continuing services in 2026;

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF OBETZ THAT:**

Section 1. The Mayor or Administrator is hereby authorized to enter into contracts, in a form acceptable to the Director of Law, with:

- Franklin Soil and Water Conservation District for Storm Water Quality, Construction Inspection, and Conservation Program Services.
- Franklin County Public Defender Commission for representation of indigent defendants in Franklin County Municipal Court.
- Franklin County Board of Health for Public Health Services and Plumbing Code Services.

Section 2. This Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public health, safety and welfare of this City, such emergency arising from the necessity to secure the timely and necessary services to be performed by the entities referenced above. WHEREFORE, this Ordinance shall be in force and take effect immediately upon its passage.
