ORDINANCE: 77 – 25

PASSED: December 15, 2025

AN ORDINANCE TO ACCEPT A DONATION FROM KIRK EXCAVATING AND CONSTRUCTION COMPANY CONSISTING OF FIBER OPTIC MATERIALS AND LABOR FOR USE AT THE OPERATIONS BUILDING AT FORTRESS OBETZ IN SUPPORT OF ZUCCHINIFEST 2025 AND OTHER COMMUNITY EVENTS, AND DECLARING AN EMERGENCY

WHEREAS, the City of Obetz hosts Zucchinifest, an annual community festival that includes live concerts as well as other public events that promote civic engagement, tourism, and economic activity within the City; and,

WHEREAS, the effective production and operation of concert and video equipment for events at Fortress Obetz – particularly the Operations Building requires reliable high-speed fiber optic connectivity between facilities; and,

WHEREAS, Kirk Excavating and Construction Company donated approximately 1,300 feet of six-strand fiber optic cable, claw clamps, a fiber connector box, and installation services by two (2) employees for eight (8) hours each to splice and connect the fiber at the Operations Building at Fortress Obetz, at no cost to the City; and,

WHEREAS, this generous donation directly supported the City's ability to operate video and production equipment necessary for the safe, efficient, and high-quality presentation of concerts and related events during Zucchinifest 2025 and will be available for use at future events, thereby serving a clear public purpose; and,

WHEREAS, the City Council finds that formal acceptance of the donation is in the best interests of the City and its residents, and that no obligation, commitment, or preferential treatment is conferred upon the donor by virtue of the donation.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF OBETZ, OHIO, THAT:

Section 1. The City hereby accepts a donation from Kirk Excavating and Construction Company consisting of approximately 1,300 feet of six-strand fiber optic cable, claw clamps, a fiber connector box, and the provision of two (2) employees for eight (8) hours each to perform fiber splicing and connection work at the Operations Building at Fortress Obetz.

Section 2. The donation accepted herein was used solely for municipal and public purposes, including but not limited to establishing fiber optic connectivity necessary to operate video, audio, and production equipment in support of concerts and related events associated with Zucchinifest 2025 and other City activities at Fortress Obetz.

Section 3. The City Council hereby expresses its sincere appreciation and thanks to Kirk Excavating and Construction Company for its generous donation of fiber optic materials and professional labor in support of Zucchinifest 2025 and the City's ongoing efforts to provide high-quality public events and amenities.

Section 4. This Ordinance is hereby declared to be an emergency measure, the immediate passage of which is necessary for the preservation of the health, safety and welfare of the citizens of the City of Obetz, such emergency arising from the immediate need to accept the donation before the end of the tax year; WHEREFORE, this Ordinance shall take effect and be in force immediately upon its passage.
