ORDINANCE: 01 – 26

PASSED: January 12, 2026

**AN ORDINANCE TO ACCEPT THE ANNEXATION OF 163 +/- ACRES FROM HAMILTON TOWNSHIP  
TO THE CITY OF OBETZ AND TO DECLARE AN EMERGENCY**

**WHEREAS**, a petition for annexation of certain territory in Hamilton Township was duly filed by the Board of Park Commissioners of the Columbus and Franklin County Metropolitan Park District; and,

**WHEREAS**, the petition was duly considered by the Board of County Commissioners of Franklin County, Ohio on October 28, 2025, and said Board approved the annexation of such territory to the City of Obetz; and,

**WHEREAS**, the Board of County Commissioners certified a copy of the Resolution approving said annexation with the map and petition to the Clerk of the City of Obetz who received the same on November 10, 2025; and,

**WHEREAS**, sixty (60) days from the date of receipt of the County Resolution granting the petition for annexation, has now lapsed in accordance with Section 709.04 of the Ohio Revised Code; and,

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF OBETZ, OHIO, THAT:**

Section 1: The petition for the annexation of 163 +/- acres, more or less, as shown on the annexation plat attached hereto as Exhibit A, to the City of Obetz is hereby accepted.

Section 2: The zoning for the parcels shall be Exceptional Use.

Section 3: The Clerk be, and hereby is, authorized and directed to make three (3) copies of the Ordinance and to each of which shall be attached a copy of the transcript of the proceedings of the City Council relating thereto and a certificate as to the correctness thereof.

Section 4: This Ordinance is hereby declared to be an emergency measure, the immediate passage of which is necessary for the preservation of the health, safety and welfare of the citizens of the City of Obetz, such emergency arising from the immediate need to begin utility extensions in advance of the park opening; WHEREFORE, this Ordinance shall take effect and be in force immediately upon its passage.
